

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 4 April 2019, in which you state the following:

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 7 May 2019.

Decision on access

A search of the CMTEDD records has failed to identify any documentation in relation to your request.

The relevant business unit has advised that each Trader Licence is determined on a case by case basis and one factor considered is whether it is in the public interest to issue a licence to an entity. There is no separate public interest guideline that exists. The business unit uses the relevant provisions in the <u>Traders (Licensing) Act 2016</u> and the <u>Traders (Licensing) Regulation 2017</u> when considering the suitability of an entity to be provided with a licence.

I note that in the case of <u>Hogan v Hinch</u> (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'.

I am satisfied that appropriate searches were completed and that no documents relevant to your request exist.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2), processing charges are not applicable for this request because no information concerning your request exists.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. A description of the access application and my decision will be published in the CMTEDD disclosure log after 11 April 2019. Your personal contact details will not be published.

Ombudsman Review
