## **Summary of impacts:**

- There is no funding available for the Music for Colleges program from 2019.
- Canberra students have access to a world class curriculum that includes music. High
  performing music students in the public education system also have access to high quality
  music tuition, ensembles and bands through the Instrumental Music Program (IMP). This will
  continue and be supplemented through additional improvements to the existing program.
- Schools and students can access other government-funded music programs including through Music For Canberra at the Ainslie Arts Centre, and music engagement activities by the Canberra Symphony Orchestra.
