I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 1 April 2022.

Specifically, you are seeking: *Please advise of the relevant insurer on risk for Frisco Direct,* ABN 99 169 927 324 on 2019.

### **Authority**

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

## **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 4 May 2022, however a further 15 working days was required for third party consultation. A decision and response is now due on 25 May 2022.

## **Decision on access**

I have decided to grant access in full to the relevant information which is included below:

The insurer in 2019 as requested was Insurance Aust Ltd T/A CGU Workers Compensation, under policy number O/15-2161 for the company Frisco Direct Pty Ltd (ABN 99169927324).
