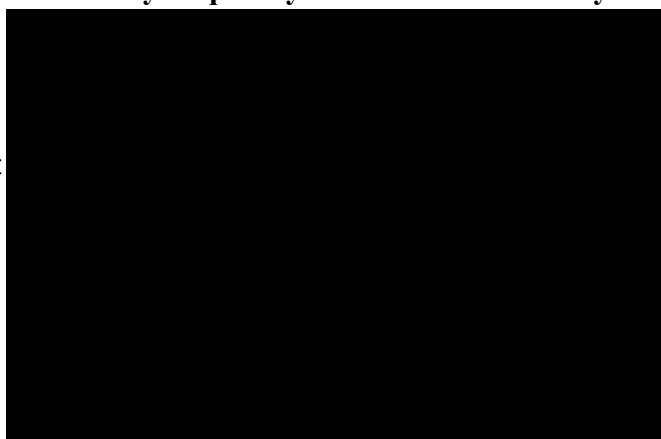

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 30 December 2018, in which you sought access to information regarding how many parking tickets were issued on 15 December 2018 at Bon Scott Crescent, Moncrieff ACT 2914.

Specifically, you are seeking: *“Written confirmation of how many parking tickets were issued on 15 December 2018 around 12 midday in the vicinity of Bon Scott Crescent, Moncrieff.”* (Part A)

It was also requested that you receive any available images regarding your offence, as you have been unable to access them online (Part B).

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 30 January 2019.

Decision on access

In response to your request searches were completed for relevant documents and 1 document was identified that falls within the scope of Part B of your request.

In respect of Part A of your request, the relevant business area which was consulted for this request has confirmed that between 12:15pm and 1:30pm, 17 parking infringement notices were issued on 15 December 2018 at that location.

I have included as **Attachment A** to this decision a schedule outlining the relevant document in respect of Part B of your request. This provides a description of the document that falls within Part B of your request and the access decision for that document.

I have decided to grant full access to the relevant document. The document released to you is provided as **Attachment B** to this letter.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because the total number of pages to be released to you is below the charging threshold of 50 pages.

Online publishing – Disclosure Log
