### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 28 October 2019, in which you sought access to:

Documents within the Date Range (1992-2019) in relation to investigations into Croatia Deakin Soccer Club, Croatia Deakin Football Club, Canberra FC and Canberra Croatia FC involving multiple blocks of land in the suburb of Deakin including:

- 1. Complaints;
- 2. Investigation reports;
- 3. Draft of investigation reports;
- 4. Expert reports;
- 5. Inspection reports;
- 6. Financial reports;
- 7. Working documents;
- 8. Referrals;
- 9. Assessments;
- 10. Advice;
- 11. Decisions;
- 12. Letters and emails;
- 13. Minutes of meetings;
- 14. Any communications or any documents between with the Australian Federal Police evidencing the Investigations; and
- 15. Any internal communications or any documents between relevant entities of Access Canberra evidencing the Investigations.

## Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 25 November 2019.

#### **Decision on access**

Searches were completed for relevant information with 201 documents being identified as being within the scope of your request. In considering these documents, I have been advised that these documents are currently being considered as part of an active investigation. Accordingly, I consider their release is contrary to the public interest pursuant to section 1.14(1)(a) and (b) of Schedule 1 of the Act.

In accordance with section 54(2) of the Act a statement of reasons outlining my decision is below.

#### Material considered

In reaching my access decision, I have taken the following into account:

- the Act; and
- the content of the documents that fall within the scope of your request.

#### **Exemption claimed**

My reasons for deciding not to grant access to the identified documents and components of these documents are as follows:

#### Contrary to the public interest information under schedule 1 of the Act.

#### 1.14 Law enforcement or public safety information

- Information the disclosure of which would, or could reasonably be expected to—
  - (a) prejudice the investigation of a contravention or possible contravention of the law in a particular case; or
  - (b) identify the existence or identity of a confidential source of information in relation to the enforcement or administration of the law.

The information found to be within the scope of your request currently forms part of an ongoing investigation being undertaken by Access Canberra and the Australian Federal Police. In reviewing these documents and taking into account advice received from Access Canberra, I have decided that release of this information would be contrary to the public interest as it would prejudice the ongoing investigation into a possible contravention of the law. Moreover, I am satisfied that the release of this information would also impact Access Canberra's ability to take appropriate action in relation to this matter. This information may be able to be released at a later date following completion of the investigation and finalisation of any actions taken as a result.

In addition, the documents within the scope of your request also contain details of individuals who have provided information to Access Canberra as part of the investigation. The release of this information could identify the existence of a confidential source of information with likely negative impacts to these individuals. I do not consider the release of these details is within the public interest.

Accordingly, I have decided to withhold from release all information found to be within the scope of your request.

#### Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)*, processing charges are not applicable for this request because no information is being released to you.

#### **Online publishing – Disclosure Log**

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log 3 days after the date of decision. #### **Ombudsman Review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act.
