## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the Freedom of Information Act 2016 (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 28 February 2020, in which you sought access to:

All documents both internally prepared and externally commissioned including reports, correspondence, briefings and meeting notes/minutes that relate to:

- the approval process for the use of Aluminium Composite Cladding (ACP) as a building product in the ACT;
- concerns raised about the use of ACP with the ACT Government;
- risk analysis regarding the use of ACP as a building product in the ACT;
- potential impacts and costs for owners and renters affected by ACP;
- potential impacts on the building industry and the ACT economy from the existing ACP; and
- options developed and considered to ameliorate impacts on individual households and the industry.


## Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

## Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 30 March 2020 however, following on from an extension and third party consultations, the due date is now 7 May 2020.

## Decision on access

Searches were completed for relevant documents and 18 documents were identified that fall within the scope of your request.

I have included as Attachment A to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.
I have decided to grant access in full to 10 documents and partial access to 6 documents relevant to your request. I have decided to refuse access to 2 documents as I consider them to be contrary to the public interest under section 1.2 and 1.6 of Schedule 1 of the Act.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as Attachment B to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

## Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act;
- the content of the documents that fall within the scope of your request;
- the Human Rights Act 2004.


## Exemption claimed

My reasons for deciding not to grant access to the identified documents and components of these documents are as follows:

## Contrary to the public interest information under schedule 1 of the Act

One document that have been identified as being within the scope of your request is fully composed of information that is considered to be contrary to the public interest information under section 1.2 of Schedule 1 of the Act as it is information that is deemed privileged under Legal Professional Privilege. This information can only be released if the parties involved agree to waive that privilege. The parties have not waived privilege.

One document that has been identified as being within the scope of your request is entirely composed of information that is considered to be contrary to the public interest under section 1.6 of Schedule 1 of the Act as it is Cabinet information. Under section 1.6 of Schedule 1 of the Act, Cabinet information is exempt from release. The purpose of this exemption is to maintain the confidentiality of the cabinet process and to uphold the principle of collective ministerial responsibility. This exemption was discussed in The Commonwealth v Northern Land Council [1993] HCA 24; (1993) 176 CLR 604 (21 April 1993). Paragraph 6 of the decision, states that:
... it has never been doubted that it is in the public interest that the deliberations of Cabinet should remain confidential in order that the members of Cabinet may
exchange differing views and at the same time maintain the principle of collective responsibility for any decision which may be made.

The document that you have requested falls within section 1.6 of the Act as it is information which has been commissioned by the Cabinet to guide it in its decision making and to assist it in its deliberations. It is therefore exempt from release under the Act.

Information that would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act

Public Interest
The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interests lies. As part of this process I must consider factors favouring disclosure and non-disclosure.
In Hogan v Hinch (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

## Factors favouring disclosure in the public interest:

(a) disclosure of the information could reasonably be expected to do any of the following:
(xiii) contribute to the administration of justice generally, including procedural fairness.

Having considered the factor above, I consider that the release of these documents may promote open discussion of public affairs and enhance the government's accountability by allowing you to have a record of the process within Government to address the cladding issue. I am satisfied that this factor favouring disclosure carries some weight. However, this factor is to be balanced against the factors favouring non-disclosure.

Factors favouring nondisclosure in the public interest:
(a) disclosure of the information could reasonably be expected to do any of the following:
(ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.

When considering the documents and factors in favour of non-disclosure, I have considered the personal information contained in the documents, including the names of people outside of the ACT Government. I consider it unreasonable to release information that could reasonably be expected to prejudice the privacy of a person or persons that
have been in contact with the ACT Government contained in the documents. I believe the release of this information may prejudice the protection of these individuals' right to privacy or any other right under the Human Rights Act 2004. I am satisfied that this factor favouring non-disclosure should be afforded significant weight as it relates to the individuals' privacy.

Having applied the test outlined in section 17 of the Act and deciding that release of personal information contained in the documents is not in the public interest to release, I have chosen to redact this specific information in accordance with section 50(2). Noting the pro-disclosure intent of the Act, I am satisfied that redacting only the information that I believe is not in the public interest to release will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

## Charges

Processing charges are not applicable for this request because the number of pages being released to you is less than the charging threshold which is 50.

## Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log after 12 May 2020. Your personal contact details will not be published.

Hi David and David,
Yesterday Nick and I met with Neil Bulless in relation to the new working group being established in relation to the Government response to cladding.

Neil advised that there was no additional funding our resources being provided. He noted that Ben Ponton had written to all DG's and Mark Brown seeking support by way of secondment of resources. Neil has identified resources from SLA and has been in discussions with the Chief Engineer in relation to resources being made available from MPC. Neil did not request any specific resources from AC at this time. He requested my representation on the Governance/Working Group, which I agreed. Nick will also attend relevant meetings etc. Over the next two weeks Neil will meet with others that have been involved in the previous response teams. He has not met with EPSDD at officer level at this stage. I anticipate that after this process it will become clearer what support Neil requires and what support we can provide. Neil noted that EPSDD resources that were previously engaged in the cladding work would not be available.

Neil outlined three priority/project areas that he has been tasked with:

1. Next phase detailed assessment of Government owned buildings - then position to government on mitigation/rectification.
2. Desktop scan of private sector buildings; and
3. Assessment of Government occupied buildings.

Nick and I outlined the areas of risk and made some suggestions around next steps. This included in relation to private buildings, where we noted that the experience from the audit of government buildings highlighted the lack of design documentation that identifies the type of cladding used and it may be a better use of time to move to physical audit/inspection rather than documentation audits. In any case, I offered assistance with respect to running reports from our systems to assist in identifying each private building, (excluding single residential buildings), through building approval data from the last 20 years. I suggested that Unit Title data would also be a good starting point with respect to private multi-residential buildings.

Neil advised that an update is to be provided to Cabinet in March 2020.
Nick and I will continue to engage with EPSDD in relation to the funding transfer and with Neil in relation to assistance he may require with the cladding response.

In terms of a response to Ben P I I suggest that we need to sort the funding transfer out and I would then be comfortable in providing resources to Ben $P$, as they are not resources we are currently relying on. It would appear however that Neil is seeking his own resources and his advice to me was that the skill set required would vary during the project. He also noted that he would be having further discussions with Ben P and Erin in relation to utilising existing EPSDD resources that undertook the original program of works. I suggest we maintain an open dialogue with Neil so we can provide assistance when required. I note that the Minister was clear that the regulatory work of Access Canberra cannot be impacted.

Let me know if you require any further information.

Hi David,
There is ongoing funding for 2 SOG B's and 1 vehicle that is scheduled to come to AC from EPSDD. I met with Bethal Sendaba (EBM EPSDD) on 26 November 2019 in relation to the transfer of funding and again followed up with Vanessa Morris in EPSDD on 6 January 2020. Funding is yet to transfer but it is my intention that the funding be transferred to AC with the positions then being temporarily transferred to the Cladding Audit Response Team. The preliminary work that was undertaken by EPSDD with assistance from AC was able to be undertaken by delaying the funding transfer. With my desire to have the funding transferred, $A C$ will at this stage be contributing the equivalent of 2 SOG B's and a vehicle.

I have this afternoon received contact from Neil Bulless who has been appointed as Coordinator General - Cladding Audit Response Team. I will meet with Neil later this week to understand further details. I note that the Cladding Audit Response Team appears to sit within EPSDD and not CMTEDD.

I'll advise of any relevant information after my meeting with Neil.

Dear Colleagues,
I refer to the message from the Head of Service (see below) announcing the formation of a focussed team, drawn from existing resources across the ACT Public Service, to progress a range of issues associated with building cladding. This work will have an initial focus on addressing existing government assets, but will also work with the private sector in terms of privately owned buildings. This is an important priority that requires our collective support through the secondment of suitably qualified and experienced officers into a new team for a period of time. As advised by the Head of Service, the new Cladding Audit Response Team is being led by Neil Bulless and managed through EPSDD.

## Colleagues

You'll recall that the Government has undertaken an extensive audit of government buildings that were identified as having potentially combustible cladding. It found that all buildings are safe for people to continue to occupy. Around 70 buildings have cladding that will require more detailed assessment and, potentially, some remediation or other actions.

We are now creating a new focussed team that will progress this important work over the coming months. The team will be led by Neil Bulless and sit within the Environment, Planning and Sustainable Development Directorate.

The team will also consider the extent of the use of potentially combustible cladding in specified private buildings, and engage with insurers, building owners and key stakeholders to make sure that the community is informed about managing any risks associated with cladding and the safety of all buildings in the ACT.

To create this team we will need to draw on appropriately qualified and experienced officials in the ACT Pubic Service. We will also engage expert industry consultants. Ben Ponton will be in touch with you asking you to nominate suitable staff to be seconded to the new team.

The creation of this team is another example of how the ACT Public Service operates as one service.

Hi Ben,
A couple of points:

1. Most of the measures appear reasonable.
2. I would suggest that EPSDD or AC discuss measures past F\&R (if not already done) - while the context for their advice would need to be clearly established (i.e. immediate actions / remediation), we are dealing largely with fire safety matters and emergency evacuation, which is their area of expertise
3. I am concerned regarding the point:

Limit use of standalone buildings with more than $50 \%$ coverage of cladding until further detailed nisk analysis of the product and building. Establish if other areas/buildings can be used for the purpose the building is needed-
$\%$ coverage is one of the 18 criteria in the risk assessment tool, and it has 3 assessed categories ( $>50 \%$ being the highest risk score) I'm not sure why this is singled out from the 18 and in doing so it could be argued we are undermining the risk assessment process. For example a building with $35-49 \%$ might be higher risk where there were other high scored criteria in the 18 assessed. I recommend we stick to the score provided by the tool as these are repeatable and agreed.

Also concerned around the term "limit use" - when, who by, whole or part etc. Again, it could create ambiguity.

As such, I suggest Moderate rated buildings are to be reviewed in relation to use, and that Fire and Rescue also engaged to provide immediate advice on these buildings. The actions are fundamentally short term fire safety solutions and I'd argue they are best placed to advise. This would need to be discussed with the Commissioner/Chief Officer however.
4. It is unclear to me where this paper fits into the process, noting that I haven't had a chance yet to discuss where the assessment team are up to at this stage.

I am assuming information will be provided to Directorates in a structured way which includes the risk rating for identified buildings and building specific advice, that can be supported by the above document as appropriate. I suggest building specific advice is necessary on the basis of the assessment teams input when I prepared the draft of the cab sub - see below. (I'm fairly sure the paragraphs below largely came from the team, and this info would be useful in guiding directorates in undertaking immediate action):

Those buildings of low risk where the level of the combustible cladding was considered minor in nature by the EPSDD inspection team, to the extent that its presence was considered to pose no nisk to the start or spread of fire to a building;

Those buildings where the only required treatment to mitigate risk to an acceptable level is the removal of combustible cladding over exits, or other targeted actions as appropriate which do not require the input of a qualified fire engineer

I hope this is constructive, and happy to discuss

## INSURANCE INDUSTRY RESEARCH INTO ACP REMEDIATION


#### Abstract

Summary The Insurance Council of Australia (ICA), together with representatives of its member companies, have been working with the Society of Fire Safety and Dr Kate Nguyen from RMIT University, on research work for practical and cost effective remediation measures for our clients (building owners) that have buildings with non-compliant combustible ACP's.

As the Identification process continues, we are finding a large number of buildings with combustible ACP's. As you are no doubt aware, where the only remediation option being considered is $100 \%$ replacement of ACP, the cost of remediation is multiple millions of dollars per building. However, as demonstrated by the large scale fire testing conducted in Dandenong last year, total replacement of ACP may not be required in all cases. For many buildings, the risk posed by ACP can be largely mitigated through remediation options other than $100 \%$ replacement.


To further investigate alternative remediation options, additional large scale testing is required. The Insurance Industry, many building owners, various governments and cladding task forces, are eager to support this proposed testing and we see the VBA as an important stakeholder in this process. There are a number of buildings in Melbourne that are delaying developing final rectification plans pending the results from this proposed testing. In the meantime, these buildings remain clad with dangerous cladding with the associated risk to the building occupants.

We understand that the VBA is reluctant to sign off on this proposed testing due to only one panel manufacturer currently participating in the test program. We would like to note that a manufacturer willing to participate in this research should be commended for this action. It is also our understanding that other manufacturers are welcome to participate in the testing program. Notwithstanding, the critical outcome of the testing program is to develop a system for fire breaks that largely mitigates the risk of ACP, demonstrated through large scale testing. This will allow building owners to move forward with remediation plans and, where appropriate, adopt more effective and efficient alternatives to $100 \%$ replacement.

The Review Group worked with individual directorates to identify ACT Government owned or occupied buildings that may have potentially combustible cladding present on the building. For some buildings, this included a visual verification on site. Other buildings did not require an inspection due to the nature of building and construction materials used. All ACT Government owned or occupied buildings were included in the initial review.

As noted earlier, the initial process did not indicate that any ACT Government buildings were deemed unsafe to occupy. Some government buildings that were identified to have potentially combustible cladding will be subject to a more detailed inspection. These inspections will depend on the building and the issues that need verification, but may include an assessment of the type, location and coverage of cladding and the fire safety protections and procedures in the building,

The review has initially focused on publicly-owned residential buildings, given the risks for vulnerable occupants. The scope of the review also includes privately owned residential buildings in the Territory.

ACT Government agencies have been working to identify any government owned or occupied buildings that may have combustible cladding, including undertaking physical inspections of some buildings to identify immediate risks to occupants.

Physical inspections of ACT Government buildings with potentially combustible cladding are continuing to take place to ensure that aluminium composite panels have been installed correctly and do
not pose an undue risk to building occupants.
During this process, no inspected building have been deemed unsafe to occupy. Inspections will be used to identify whether buildings require any building work or other fire safety or risk mitigation. The review work does not have a fixed end date at this stage - it is an ongoing consideration of cladding and related matters.

Officials from across jurisdictions share information on their reviews, including methods for assessing risks and potential rectification options. The ACT also participates in the Building Ministers' Forum and its advisory committees. National work to date includes amending the National Construction Code to further clarify the standards that apply to external cladding and fire safety. In August 2018, the Forum also agreed to ask Standards Australia to develop an Australian Standard for permanent labelling of aluminium composite panels to be mandated through the National Construction Code.

## ACT Government's building cladding review

The ACT Government established a Review Group within Government to undertake a review (the Review) to identify whether Government buildings require any building work or other fire safety or risk mitigation due to cladding. The group is collating information from previous ACT Government desktop audits and physical inspections of ACT Government buildings (both those owned and tenanted) and has started detailed assessments for higher risk ACT buildings that have been identified as having potentially combustible cladding materials and or affixed in a manner that increases risk.

The most important consideration in the Review is the risk to occupants and the public. The intent is to identify any buildings that have cladding is installed in a way that poses an undue risk to occupants and take appropriate action to resolve those risks. It is important to note that risks and compliance are not based solely on the cladding material itself, but also on the manner and location
in which it is used. All of these factors may not be clear without a more detailed assessment. The review is a significant exercise that will take some time. The Review is ongoing.

The Review Group is currently doing preliminary work to identify privately owned properties that may potentially have cladding that is a high risk for occupants. The Review Group welcomes any information that members of the public or industry may have about the types of cladding on privately owned buildings in the Territory.

We understand that the NSW laws restrict the use of certain types of cladding on some buildings in a way similar to the existing prescriptive compliance pathways in the National Construction Code. Some jurisdictions have introduced new processes to require a review of any use of aluminium composite panel (ACP) or other types of combustible cladding. In the ACT, we already have strong processes in relation to building approvals and fire safety that other jurisdictions did not or do not have. We will continue to use the processes we implemented in 2009-10 to assess the use of ACP on medium-high rise buildings in the Territory, and continue to work with our colleagues nationally on permanent labelling of ACPs so that the type of cladding can be readily identified and used appropriately.

## Polyethylene Aluminium Composite Panels (ACP) - work underway

As you may be aware the ACT Government has established a cross-government working group to determine how many buildings may be impacted by the installation of ACP.

This is in-line with work of other jurisdictions who are also undertaking such activity.

ACP are predominantly used on the exterior facade of commercial buildings or as decorative cladding, particularly in newer buildings or those recently refurbished.

There is a risk that some panels may have combustible cores which could result in an increased fire spread. However it is important to note that in the ACT commercial buildings have a high level of fire safety measures in place to support building occupants in the unlikely circumstance of fire.

Areas of government are currently undertaking a series of investigations or audits into the buildings they may own or have tenants occupied in. This is being undertaken in a number of ways including through independent assessment, through desk top audits and physical inspection where needed.

One of the first areas of government to have completed the initial investigation is ACT Health. An independent assessment has confirmed that the Centenary Hospital for Women and Children - a three storey building at Canberra Hospital - has some ACP panels as part of its facade.

Due to the fire management systems in place at the building, the risk is low, but health has made a proactive decision to remove and replace affected panels. Staff at the hospital have been informed of the upcoming replacement works, as will the community today.

As mentioned above, the hospital has robust fire management arrangements in place. Just this month these were reviewed by the ACT Emergency Services Agency and were found to be compliant.

As the working group continues its investigations we may identify further buildings where panels will need to be replaced. The safety of our community and staff is our paramount consideration at all times.

We will also continue to keep our staff, unions and broader community informed of this important work.

Thank you for your letters about the audit of the use of overseas products as cladding material in Australia.

The ACT Construction Occupations Registrar (the Registrar) has sought advice from building certifiers in the ACT about the use of these products. I am advised that at this stage both the Registrar and ACT Fire Brigade are not aware of the specific product being used on buildings in the ACT.

I note your concerns about the import of products into Australia and the potential risk that poses to occupants of buildings. The Building Code of Australia is clear about the use of products. All building products must comply with the relevant Australian Standards. These standards are enforced in the first instance through the building certifier issuing a building approval, and are monitored through the various inspections required of the building certifier during the construction process.

Any departure from the performance requirements under the building code requires an alternative solution. Alternative solutions are assessed and reviewed by industry professionals, the building certifier and the ACT Fire Brigade.

To date, the states and territories have been working with the Commonwealth Government through the Australian Building Codes Board, and await the outcomes of the inquiry into the Lacrosse fire incident in Victoria.

I note your concerns about the free trade agreement with China. I also recognise the measures in place in the ACT to protect the public through the statutory building approval process, in particular the engagement of relevant professionals throughout that process.

Thank you for raising this matter with me. I trust that this information is of assistance.

## Critical date and reason

1. In the normal course of business.

## Background

2. On 26 May 2015 and 2 June 2015 the Construction Forestry Mining and Energy Union wrote to you in relation to imported building products being used in the ACT and the associated risk to community.
3. The two products that were bought to your attention were aluminium cladding that was used on a building that was subject to recent fire in Docklands, Victoria; and engineered wood products including structural plywood used in bracing, flooring and concrete formwork.

## Issues

4. The ACT Construction Occupations Registrar (Registrar) is seeking advice from building certifiers in the ACT in relation to the use of the products. At this stage both the Registrar and ACT Fire and Rescue are not aware of the specific product being used on buildings in the ACT.
5. From a regulatory perspective, the National Construction Code - Building Code of Australia (building code) is clear in relation to the use of products. All building products must comply with the relevant Australian Standards. These standards are, in the first instance, enforced through the building certifier issuing a building approval and are monitored through the various inspections that are required to be undertaken by the building certifier during the construction process. Any departure from the performance requirements under the building code requires an alternative solution. Alternative solutions which form part of the building code are assessed, reviewed and approved by industry professionals, including the building certifier and ACT Fire and Rescue.
6. It is the view of the regulator that there are measures in place in the ACT to protect the public through the statutory building approval process and in particular the engagement of relevant professionals throughout that process. These matters form part of the discussion paper on the review of the Building laws of the ACT.
7. The Construction Occupations Registrar has been made aware of an investigation and audit program being undertaken by the Victorian regulator. Upon completion of the audit by the Victorian regulator further action may be undertaken.

## Consultation

8. The Construction Occupations Registrar is working with the ACT Fire and Rescue in relation to this matter and that word is ongoing. The Construction Occupations Registrar will be working with licensed building certifiers in order to establish the extent, if any, of the use of the products in the ACT and the associated risk to community.

## Financial

9. There are no financial implications to Government in relation to the content of this brief.

## Risks/ Sensitivities

10. There are no risks/sensitivities in relation to the matters discussed in this brief at this stage.

## Media

11. The building fire in Victoria received media attention. There has been no media contact in relation to the use of the products in the ACT. At this stage it is not likely that there will be an media implications

Dear Chief Minister,
I write to you in relation to an urgent matter of public safety.
As you are most likely aware there is significant community alarm following the November 2014 fire at the Lacrosse Docklands apartment building (673-675 La Trobe Street Melbourne).

This frightening incident highlights that Australia has no mechanism by which it can verify if products made and certified overseas as meeting Australian standards, do actually conform to those standards. In short, we have no way of knowing if these products are safe.

A report arising out of this incident and produced by the Metropolitan Fire Brigade (MFB) confirmed suspicions that the aluminium/polyethylene external cladding used in this instance does not meet the requirements of the Australian Building Code due to the fact that it was combustible and as such contributed to the fire spreading at the extraordinary rate that it did.

Although the Lacrosse Docklands fire was the first incident of this kind in Australia, the MFB outlined how similar products have exacerbated the spread of fire in high rise buildings in fire incidents in the United Arab Emirates, the United States, South Korea and France. These fires resulted in nine deaths.

The Fire Protection Association Chief Executive described the issue as a "time bomb" with tens of thousands of apartment buildings nationwide at risk because of the widespread use of the Alcuobest and numerous other aluminium cladding products with a plastic core. Our information would suggest that the product and similar products which have a plastic core (specifically those with less than $70 \%$ mineral fibre in the core) is not of a fire resistant grade suitable for use in projects such as high rise buildings. The use of these products is of considerable concern.

We are alarmed that when the CSIRO tested the product for combustibility they found sustained flaming on the specimen at 55 seconds into the test. This resulted in the test being terminated at 93 seconds due to excessive flaming and smoking. These results should raise serious questions as to the suitability of allowing this product in other applications which are non-high rise buildings, particularly in cases where the public is at risk, such as in shopping centres, kindergartens, nursing homes, schools etc.

In Victoria the Victorian Building Authority has written to all building surveyors, including municipal building surveyors, and commercial builders, domestic builders, architects and designers asking them to clarify the extent of the use of this and other non-compliant cladding. The problem with this single-based approach is that the recipients of the letter do not have an obligation to respond. They also might consider their product technically compliant even when its application might still be dangerous and the product may not as a matter of fact actually be compliant.

As a matter of urgent public safety we are formally requesting that you direct the relevant government department to conduct an audit of the use of this product with a view to compelling building surveyors, builders, architects and designers to outline wherever the use of this product has occurred in your Territory. The purpose of the audit would be to ascertain the extent of the problem, then place the information on the public record along with a site-specific explanation to be shared with the at-risk public. This information would include the methods used to determine the products respective applications are safe and/or what remedial action will be taken to ensure that is the case.

The Australian Industry Group stated to the Australian Government last year that many respondents to their survey outlined that manufactured goods imported from China do not meet Australian safety and quality regulations and standards; and in addition to that the removal of tariffs under an Australia-China FTA may exacerbate this situation. They recommended that conformity with Australian safety and quality standards needs to be strengthened and a process developed for legal enforcement of insurance claims and contract breaches.

Dealing with this challenge in the way we propose would be a good first step in showing that Governments are protecting Australians from unsafe imported products and also defend Australian manufacturers who must ensure that their products reach Australian Standards.

We look forward to your response to our proposal within two weeks of the receipt of this letter.
