

# FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 14 January 2021, in which you sought access to records relating to property damage and maintenance, including insurance claims and complaints made against a taxi with registration number TX8.

Specifically, you are seeking: We are instructed by in relation to a motor vehicle accident claim involving taxi with registration . We seek access to all property damage and maintenance/repair records, insurance claims and complaints made against the taxi with registration for the period 11 August 2017 to 11 August 2019 inclusive. This taxi was involved in an accident with a pedestrian on 11 August 2018.

#### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 16 February 2022.

#### Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information provided by you which includes taxi registration number and names of the owner and driver.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

#### Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as no documents are being released to you.

#### **Online publishing – Disclosure Log**
