## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 23 November 2021, in which you sought access to all documents related to

Specifically, you are seeking: "All documents held by the Construction Occupations Registrar in respect of defects in the property

for the period from 11 September 2015 to date".

The scope of this request was clarified on 13 December 2021 to "All documents relating to existence and rectification of

for the period from 11 September 2015 to date".

### Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 27 January 2022 however, following third-party consultations and the requested extension of 14 working days, the due date is now 18 February 2022.

### Decision on access

Searches were completed for relevant documents and a number of documents were identified that fall within the scope of your request, however based on the information provided by Access Canberra, the regulatory arm of CMTEDD,

I have decided to refuse access to all information in relation to this matter. In accordance with section 54(2) of the Act a statement of reasons outlining my decision is below.

### Material considered

In reaching my access decision, I have taken the following into account:

- The requirements of the Act
- The contents of identified documents
- Advice received from the relevant business unit within Access Canberra

# **Exemption claimed**

My reason for deciding not to grant access to the identified documents is that the information you have requested is contrary to the public interest information under schedule 1 of the Act.

Access Canberra, the regulatory arm of CMTEDD has advised that this matter is currently under active investigation and in a negotiation phase with the builder. The release of this information at this stage could prejudice the ongoing furtherment of these negotiations and potentially set back a successful resolution of the issues.

Accordingly, I consider this information to be contrary to the public interest under section 1.14(1)(a) of schedule 1 and have decided to refuse access to this information at this time.

# Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as no documents are being released to you

# **Online publishing – Disclosure Log**
