### **Decision Maker**

I am authorised under section 22 of the Act to make decisions on access to documents, and liability for charges, for the Chief Minister, Treasury and Economic Development Directorate (CMTEDD).

### **Charges**

I have decided, under section 29, of the Act not to impose processing charges for this request.

### **Identification of Documents**

In considering your request under the Act, I have interpreted your application to cover any documents related to the 2014-15 Budget consultation submissions for those organisations and individuals listed above, that may have been generated as part of an
