My 5 year old son currently goes to Good Shepherd Catholic Primary School in Amaroo. We made this decision to send our son here as there were very few options for us in the Public School system. Our catchment area is the mega school in Harrison (many suburbs from Forde), even though there is a public school in Bonner only one suburb away. I want my son to go to a dedicated Primary School which we do not have an option for in the Gungahlin area, as the majority of schools are mega schools catering for primary and secondary schools.

With the change in funding there will obviously be increases in our school fees and we may have to look at the public system again, but do not believe that the public system gives us any positive options to do this.

Our family is happy to pay school fees to allow us to attend Good Shepherd, but will not be able to afford high increases. Which will then put extra pressure on the very limited public school system in the Gungahlin area.

I urge you to reassess these funding cuts so that all families in the Gungahlin area can have a choice of where to send their children that is reasonably priced and meets their location and educational needs.

Dear Minister

This letter is to ask for your commitment to advocate to reverse the Commonwealth Government's proposed cuts to Catholic schools in the ACT, with a particular focus on St Thomas More's Primary School in Campbell. We are writing to you because we have young children at St Thomas More's -

- and we are greatly worried about how the school can continue to deliver a quality, valuesbased education to our children if the funding cuts are not reversed.

Urgent changes to the announced funding proposals are necessary to prevent the major, unfair anomaly of children and teachers at St Thomas More's primary having their funding cut as part of the cuts to ACT Catholic schools' funding from \$109m in 2017 to \$107m in 2027 - while Australian Government funding to ACT government schools - like Campbell Primary, which shares an oval with St Thomas More's - will rise by 145% over this same period.

The basis for the proposed cuts to St Thomas More's primary is a comparison between the socioeconomic status of Campbell with the area around the Shore elite private school in Sydney. The relevant comparison should, instead, be with the primary school across the oval from St Thomas More's - Campbell Primary. The elite Shore school bears no similarity with the simple facilities and austere financial situation of St Thomas More's primary. The only similarity may be the dedication and vocational commitment of St Thomas More's teaching staff - who are exceptional.

We understand that, while ACT Catholic school funding between 2017 and 2027 will fall from \$109m to \$107m, salaries and other costs are expected to rise by more than \$50m. Without a reversal of the proposed funding cuts and an equitable funding allocation to government and Catholic schools in the same catchment areas, we do not see how the talented teachers at St Thomas More's and other Catholic schools can be retained and paid at rates that will be competitive with the government schools.

Leversing the proposed cuts will prevent a likely flight of children to already under pressure government schools - and a resulting decline in the quality of the education they can provide to ACT children. Any increase in the number of children leaving the Catholic system to the government system will increase the cost to taxpayers as it costs much more for the Commonwealth and State/Territory governments to educate a child in the government sector than it does when they are educated in the Catholic systemic school system.

St Thomas More's primary is a small school with basic facilities. It does, however, have gifted and dedicated teachers who have a deep understanding of each child and how each child learns most effectively. Its school community is close and supportive. You can feel this when you walk into the school. The Commonwealth Government's proposed funding cuts are risking this school's future right now. Already, at this critical period for enrolments for next year, the numbers of parents visiting and enquiring at the school are greatly reduced - because of the fear and uncertainty created by the announced cuts.

we seek your commitment to advocate for a reversal of this decision by the Commonwealth government and should there still remain a shortfall in the ACT, that you will support additional funding for the ACT Catholic systemic school system. If funding cannot be retained in the ACT Catholic school system, the implications for students in Catholic and government schools could be disastrous for children and their families.

Much has been said about the fairness of the current funding proposal for Australian schools. However, there are serious inequities evident between government, Catholic and independent school sectors:

- · 29 Catholic systemic schools in the ACT will be affected by the cuts
- 3 independent Catholic schools will be affected by the funding shortfall
- Within a ten year period, Catholic systemic school funding will fall from the current level of \$109m to \$107m despite current projections indicating costs are expected to rise by \$50m within the same time period

Within the same ten year period, federal funding to ACT government schools is set to rise by \$145% although the level of ACT government funding to Catholic schools is one of the lowest in the country.

The ACT Enrolment Census August 2015 indicates thousands will be affected in ACT Archdiocesan schools:

- 14 429 students
- 552 Aboriginal/Torres Strait Islander students
- 734 students with disabilities
- 873 lay teachers
- 250 support staff

Why do 14 429 students deserve fewer resources than their counterparts in ACT government schools? Why is there an expectation that parents in Catholic schools can fund the shortfall, despite there being evidence to the contrary? Why should the tax dollars of these parents be used to fund increases to government school students while their own children bear the brunt of persistent financial cutbacks over the next decade?

What will happen to 1123 teachers and support staff and their families if estimated wage growth is projected to be \$40m but federal funding does not keep up with costs of rising inflation and reduces financial support altogether?

It is grossly inaccurate to state that this proposal is fair and it is playing Russian roulette with the lives of thousands of people. The effects of education are lifelong and this decision will impact our youngest generation. This was not the intent of the original Gonski review during the Gillard government and we ask that urgent steps to be taken to address the serious inequities being proposed by the current government.

Ministers and Senator, I am gravely concerned about the pending reductions in funding for Catholic schools. Catholics do not seek special treatment, rather a fair allocation alongside state/territory schools and independent private schools. To target Catholic schools with outright reductions in funding, and significant



reductions per capita attendance, while government schools maintain funding levels and account for rising costs in the out-years, will cause a significant rise in fees that families pay at Catholic schools. This rise in fees will cause these families significant further financial stress, and will likely cause some families to withdraw their children from catholic education and into government schools.

The most optimistic projections of the recently declared budget ramifications for catholic school funding are quite dire. For many decades, Catholic education has enabled Catholic parents to follow their faith by providing their children with a faith based education - at a fair cost above the free provision of government schooling. And indeed, the catholic education system across the nation has relieved the overall burden on the government schooling system, and its overall cost to the taxpayer.

I ask that you promote reconsideration of the education funding arising from the recent federal budget amongst your peers in government and parliament. In particular, I ask that the relative funding levels for Catholic schools be re-examined, and a fair allocation be applied, in line with historical principles and trends.

"Dear Yvette Berry, I am writing to express my concerns regarding the funding cuts recently announced for Catholic schools in the ACT. This will negatively impact our school, St Thomas More's Primary in Campbell. These cuts will affect the choices and abilities of parents to choose where to send their children to school because these cuts will further disadvantage the most disadvantaged of us. The families who already experience some financial difficulties will be further placed under pressure and their children are the ones who will miss out. It's horrifying to think that these students could be further disadvantaged by missing their chosen extra-curricular activity. Other families will feel they have no choice but to move their children to a school not of their choosing as their children require additional assistance, which after these cuts are put into place, may no longer be available, or reduced so that the families feel they are disadvantaged by attending a Catholic school. These funding cuts will affect the students, their families and the staff at St Thomas More's by affecting necessary programmes like the Extension Classes, Learning and Student Support, our schools ability to employ necessary Literacy and Numeracy Coordinators, the Defence Student Transition Aide who assists our high number of Defence students who are already disadvantaged by frequent disruptions to their education due to necessary relocations of their families. Even the families who are able to pay and do not require the additional educational supports will be negatively affected as the children are separated from friends who are forced to attend a different school. I would also like to mention the families who volunteer their time at the school; some of which will need to cease or decrease their volunteer work at the school to insure they can make the short-fall economically in their households. These people are the reason our swimming carnivals go ahead each year. Lastly, as student

numbers drop in Catholic schools they increase in the public system. Public school students are set to receive more funding than their Catholic counterparts, so this is not a saving. Public schools will receive additional funding for the additional students and yes, it is easy to purchase more books, but you cannot make the oval, the library, the carpark or a new school room without disrupting the students and staff of the public schools. The students who receive the additional services like learning support in the public system now, will have to make room for other students with the same or greater needs. No one wins. Thank you for your time."

Dear Ms Berry

This letter is to ask for your advocacy to reverse the Commonwealth Government's proposed cuts to Catholic schools in the ACT, with a particular focus on St Thomas More's Primary School in Campbell. We are writing to you because we have young children at St Thomas More's — and we are greatly worried about how the school can continue to deliver a quality, values-based education to our children if the funding cuts are not reversed.

Urgent changes to the announced funding proposals are necessary to prevent the major, unfair anomaly of children and teachers at St Thomas More's primary having their funding cut as part of the cuts to ACT Catholic schools' funding from \$109m in 2017 to \$107m in 2027 - while Australian Government funding to ACT government schools like Campbell Primary, which shares an oval with St Thomas More's - will rise by 145% over this same period.

The basis for the proposed cuts to St Thomas More's primary is a comparison between the socioeconomic status of Campbell with the area around the Shore elite private school in Sydney. The relevant comparison should, instead, be with the primary school across the oval from St Thomas More's - Campbell Primary. The elite Shore school bears no similarity with the simple facilities and austere financial situation of St Thomas More's primary. The only similarity may be the dedication and vocational commitment of St Thomas More's teaching staff - who are exceptional.

We understand that, while ACT Catholic school funding between 2017 and 2027 will fall from \$109m to \$107m, alaries and other costs are expected to rise by more than \$50m. Without a reversal of the proposed funding cuts and an equitable funding allocation to government and Catholic schools in the same catchment areas, we do not see how the talented teachers at St Thomas More's and other Catholic schools can be retained and paid at rates that will be competitive with the government schools.

Reversing the proposed cuts will prevent a likely flight of children to already under pressure government schools and a resulting decline in the quality of the education they can provide to ACT children. Any increase in the number of children leaving the Catholic system to go to the government system will increase the cost to taxpayers as it costs much more for the Commonwealth and State/Territory governments to educate a child in the government sector than it does when they are educated in the Catholic systemic school system.

St Thomas More's primary is a small school with basic facilities. It does, however, have gifted and dedicated teachers who have a deep understanding of each child and how each child learns most effectively. Its school community is close and supportive. You can feel this when you walk into the school. The Commonwealth Government's proposed funding cuts are risking this school's future right now. Already, at this critical period for enrolments for next year, the numbers of parents visiting and enquiring at the school are greatly reduced - because of the fear and uncertainty created by the announced cuts.

This is decision that needs to be reversed urgently.


