Hi Kelly,

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

On 15 October 2019 in accordance with section 41 of the Act, you agreed to a 20-day extension to the due date of your application so you could seek further instructions from your client. The new due date to provide a decision on your access application is 12 November 2019.

On 11 November 2019 Kelly-Jane Yule (Freedom of Information Coordinator) of this office wrote to you requesting any further information with respect to this request and requested that a response be provided by COB on 11 November 2019. As of 12 November 2019, no further information has been provided.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided, including a telephone discussion between and the Supervisor of the Building

Services Shopfront where it was determined that the documents you are seeking access to could be located on the Territory lease file held by EPSDD.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2), processing charges are not applicable for this request because no documents are being released to you.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log.
