# FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 18 June 2020, in which you sought access to "...the (a) operating statement, (b) balance sheet and (c) cash flow statement for the General Government Sector for the period ending 30 April 2020 with figures for the (i) year-to-date and (ii) estimated outcome for 2019-20".

## **Authority**

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance of section 40 of the Act, CMTEDD is required to provide a decision on your access application by 16 July 2020.

#### **Decision on access**

Searches were completed for relevant documents and one document has been identified that falls within the scope of your request. I have decided to grant full access to that document.

I have included as <u>Attachment A</u> to this decision the schedule of relevant document. This provides a description of the document that falls within the scope of your request and the access decision for that document. The document released to you is provided as Attachment B to this letter.

#### **Additional Information**

In accordance with section 14 of the Act, CMTEDD currently hold a General Government Sector (GGS) Operating Statement including the year to date actual, year to date budget and variance amounts. This document accords with part (a) of your request.

CMTEDD do not currently hold, and as such has not been provided, a GGS Balance Sheet and Cash Flow Statement for the period ending 30 April 2020.

Consolidated financial statements are not generally produced on a monthly basis, rather, and in accordance with section 26 of the Financial Management Act 1996 (FMA), these financial statements are usually prepared and published on a quarterly basis.

Given the current health emergency and the fast-moving uncertain fiscal environment, the GGS Operating Statement for the period ending 30 April 2020 was produced for internal monitoring purposes. This Operating Statement has been produced based on year to date budget information which may be pro-rata in nature in some circumstances.

In accordance with the FMA, the next consolidated set of financial statements as part of the June Quarter Consolidated Financial Report (2019-20 Interim Result) will be available within 60 days of the end of the quarter (by no later than 29 August 2020). The Government has also indicated that it will provide an update to the budget position-in late August 2020.

## Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because the total number of pages to be released to you does not exceed the charging threshold of 50 pages.

# Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log.
