## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 9 March 2022, in which you sought access to copies of any inspections by Access Canberra, or Sports and Recreation, as per the lease requirements, regarding safety, pool maintenance and general cleanliness of Glencora Pty Ltd located on Block 2, Section 22 - 1, 3, 5 IRVING STREET, Phillip, ACT 2606.

## Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 7 April 2022.

#### **Decision on access**

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided. The Information Access team also consulted Worksafe ACT and ACT Health, however no information relevant to your request were found.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

#### Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2) processing charges are not applicable for this request because there are no documents available to be processed.
