

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act) received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 21 February 2022, in which you originally sought access to:

Any correspondence (including but not limited to emails, email attachments, and letters) from and to the Chief Minister's office (between the 1st November 2012 and the 31st October 2021), containing the following phrases:

- "Silk Road Economic Belt"

- "Silk Road Economic Belt and the 21st Century Maritime Silk Road Initiative"

On 21 February 2022 I wrote to you to inform you that I intended to refuse to deal with you application under section 43(1)(a) of the Act.

Your office responded on 23 February 2022 with a revised scope of:

 Any correspondence to or from Chief Minister's office from the 1st of January 2018 until 1st of January 2021 regarding Chinese Government investment in infrastructure in the ACT (including but not limited to Ministerial briefings, emails, email attachments etc.)

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 23 March 2022.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because no documents are being released to you.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. A description of the access application and my decision will be published in the CMTEDD disclosure log.

Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in CMTEDD disclosure log, or a longer period allowed by the Ombudsman.
