# **Christmas Shutdown and Christmas / New Year Public Holidays 2023 Advice**

### **Introduction / Purpose**

- 1. To advise directorates and agencies of:
  - the 2023 Christmas shutdown period for employees covered by the common terms of the ACT Public Sector (ACTPS) enterprise agreements; and
  - the dates of the Christmas/New Year public holidays.

### **Application**

- 2. This advice should be considered by:
  - HR directors and supervisors / managers across the ACTPS; and
  - Shared Services

### **Key Legislative Provisions**

3. Clause F11.3 (2021-2022 EA) or clause E11.3 (2023 EA) of the common terms of enterprise agreements identify the Christmas shutdown period as the business days between 28 December and 31 December inclusive.

### **Principles**

4. Employees covered by the common terms are entitled to two days of paid absence during the Christmas shutdown period, with the exception of casual employees and part-time employees whose regular part time hours do not fall during the Christmas shutdown period.

### **Procedure**

- 5. Part-time employees whose regular part time hours fall on either of the two Christmas shutdown days are entitled to a pro-rata paid absence based on the number of part time hours normally worked on those days.
- 6. The public holidays, additional public holidays, and two days of paid absence during the 2022 Christmas/New Year period are as follows:

Monday 25 December 2023	Christmas Day declared public holiday
Tuesday 26 December 2023	Boxing Day declared public holiday
Wednesday 27 December 2023	Treated as a public holiday— common terms clause F10.4.1 (2021-2022 EA) or clause E10.4.1 (2023 EA)

Thursday 28 December 2023	Shutdown paid absence – common terms clause F11.3 (2021-2022 EA) or clause E11.3 (2023 EA)
Friday 29 December 2023	Shutdown paid – common terms clause F11.3 (2021-2022 EA) or clause E11.3 (2023 EA)
Monday 1 January 2024	New Year's Day declared public holiday

- 7. Only employees who are rostered, or who are directed to work, are required to attend for duty during the Christmas shutdown period. These employees will be entitled to take the equivalent time off in lieu at an agreed alternative time, or to receive a payment equivalent to the time worked, in accordance with common terms clause F11.5 (2021-2022 EA) or clause E11.5 (2023 EA), for non-shift workers; or clauses F11.6 and F11.7 (2021-2022 EA), or clauses E11.6 and E11.7 (2023 EA), for rostered workers.
- 8. Employees who work during the Christmas shutdown period should note that the two Christmas shutdown days **are not** public holidays and **do not** attract public holiday rates.
- 9. Employees who work on any of the public holidays during the Christmas/New Year period will be entitled to receive payment for time worked on the actual day at public holiday rates.
- 10. Where employees are covered by different entitlements to those set out above, their entitlements shall be as specified in their relevant enterprise agreement. This includes enterprise agreements covering, medical practitioners, nurses and midwives, teachers (at both Education Directorate and CIT) and CIT general staff, among other employees.
