FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 5 August 2024.

Specifically, you have sought access to the following information:

- “... the number of traffic infringements issued between 1 June 2023 and 27 May 2024 for parking on verges (nature strips), footpaths, and dividing strips for the following streets in Griffith, ACT: Babbage Crescent, Barrallier Street, Bell Street, Bremer Street, Carstensz Street, Gregory Street, Hartog Street, Hovell Street, Jansz Crescent, Wells Gardens.”

Authority

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. Therefore, a decision is due by 16 September 2024.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges
