## **FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 21 January 2026. Specifically, you have sought access to the following information:

*“A list of all contracts awarded to Vista System Pty Ltd ACN135056736 ABN 88 135 056 736 for the following financial years: 2020-2021 2021-2022 2022-2023 2023-2024 2024-2025, to include the current financial year up until now.”*

The above scope was confirmed with you via email on 27 January 2026.

### **Authority**

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days.

Therefore, a decision is due by 5 March 2026.

### **Decision on access**

Thorough searches of CMTEDD records have failed to identify any documentation in relation to your request. The searches were conducted using the information you provided. The business area in their response to us advised:

*“The search of our Contracts Register has not delivered any results meeting the criterion provided. In instances where companies have a similar name, their ABN numbers did not deliver a match to the details supplied in the FOI request. We rely on the information of contracts notified in the contracts register and meeting the notifiable threshold of \$25,000. We do not have visibility otherwise.”*

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

## **Charges**

Processing charges are not applicable for this request as no documents are being released to you.

## **Online publishing – Disclosure Log**

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a [disclosure log](#). Your original access application and my decision will be published on the CMTEDD disclosure log. Your personal contact details will not be published.

## **Ombudsman Review**


