

## **FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 4 March 2026.

Specifically, you have sought access to the following information:

### **Authority**

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### **Timeframes and Consultation**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. Therefore, a decision is due by **20 April 2026**.

On **11 March 2026**, a Freedom of Information Coordinator sent you an email informing you that the information you are requesting was not available on Treasury’s website due to administrative oversight. After receiving your access application, Treasury updated the website. The information you requested is now publicly available and you were provided with this link in the email of 11 March 2026.


