#### Request for documents

I refer to your letter of 28 August 2014 addressed to the Under Treasurer of the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) in which you seek access to documents under the *Freedom of Information Act 1989* (the Act) relating to a submission you made to the Under Treasurer for consideration in the 2014-15 Budget proposing an airfield at Williamsdale.

#### **Decision Maker**

I am authorised under section 22 of the Act to make decisions on access to documents, and liability for charges, for the Chief Minister, Treasury and Economic Development Directorate (CMTEDD).

#### Charges

I have decided, under section 29, of the Act not to impose processing charges for this request.

#### **Identification of Documents**

In considering your request under the Act, I have interpreted your application to cover any documents related to your 2014-15 Budget consultation submission proposing an Airfield at Williamsdale that may have been generated as part of an assessment process. I note that you have excluded the submission itself in your request.

Officers of CMTEDD have conducted searches of paper and electronic files for documents that may relate to your request and email correspondence has been located in the Budget Coordination and Reporting Branch, and Land Development and Corporate Division.

#### **Decision on Access**

I have decided to release to you, in full, the identified correspondence; a copy is enclosed with this letter.

## **Internal Review**

Under section 59 (1) of the Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Director-General.
