FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 5 July 2019. Specifically, you are seeking access to the following:

- List of Unpaid Australian traffic infringement notices for the year 2018, covering all diplomatic vehicles in Australia – broken down by Embassy/Consulate, amount of unpaid infringements, the offences and dollar amount.
- List of Unpaid Australian traffic infringement notices for the year 2017, covering all diplomatic vehicles in Australia – broken down by Embassy/Consulate, amount of unpaid infringements, the offences and dollar amount.
- 3) List of Unpaid Australian traffic infringement notices for the year to date 2019, covering all diplomatic vehicles in Australia broken down by Embassy/Consulate, the offences amount of unpaid infringements and dollar amount.
- 4) Any document, photograph, or video relating to infringement notices issued to Embassy/Consulate staff in Australia.

On 5 July 2019 you were advised that CMTEDD can only supply information on vehicles registered in the ACT.

On 8 July 2019 you agreed to refine the scope of point 4 above to only photographs and video footage.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 23 August 2019.

Third Party Consultation

In making this decision, third party consultation was completed in accordance with section 38 of the Act. The views of the identified third party were considered in making this decision.

Decision on access

Searches were completed for relevant documents and 46 documents were identified that fall within the scope of your request. I have decided to grant partial access to all 46 documents relevant to your request.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act;
- the content of the documents that fall within the scope of your request;
- the views of the relevant third party; and
- the Human Rights Act 2004.

Exemption claimed

My reasons for deciding not to grant you full access to the identified documents are as follows:

Public Interest

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process I must consider factors favouring disclosure and factors favouring non-disclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'. Section 17(1) of the Act sets out the test to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Factors favouring disclosure (Schedule 2 section 2.1)

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factor in favour of disclosure is relevant to determine if release of the information contained within these documents is within the 'public interest'.

- (a) disclosure of the information could reasonably be expected to do any of the following:
 - (ii) contribute to positive and informed debate on important issues or matters of public interest.

Having considered the above factor, I consider that the release of the requested documents associated with unpaid traffic infringements for diplomatic vehicles for the years 2017, 2018 and 2019 within the Australian Capital Territory may contribute to open, positive and informed debate on important issues or matters of public interest.

Factors favouring non-disclosure (Schedule 2 section 2.2)

As required in the public interest test set out in section 17 of the Act, I have also identified the following public interest factor in favour of non-disclosure that I believe is relevant to determine if release of the information contained within these documents is within the 'public interest':

- (b) disclosure of the information could reasonably be expected to do any of the following:
 - (ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.

When considering the documents and factors in favour of non-disclosure I consider that it is unreasonable to release the names of private individuals and the vehicle registration plate details contained in the documents as this is personal information that is not publicly available in this form. I believe release of this information may prejudice the protection of these individuals' right to privacy or any other right under the *Human Rights Act 2004*. I am satisfied that this factor favouring non-disclosure should be afforded significant weight as it relates to individuals' privacy.

Noting the pro-disclosure intent of the Act, I am satisfied that redacting only the personal information that is not in the public interest to release, whilst releasing the rest of the information, will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2) processing charges are applicable for this request because the total number of pages to be released to you exceeds the charging threshold of 50 pages. However, the charges have been waived in this instance in accordance with section 107(2)(b) of the Act.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision in response to your access application together with the documents that are being released to you will be published in the CMTEDD disclosure log 3 days after the date of my decision. Your personal contact details will not be published. You may view the CMTEDD disclosure log at: https://www.cmtedd.act.gov.au/functions/foi/disclosure-log.

Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek a review of this outcome by the Ombudsman under section 73 of the Act within 20 working days from the day that my decision is published in the CMTEDD disclosure log, or a longer period allowed by the Ombudsman.
