FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 29 August 2024.

Specifically, you have sought access to the following information:

Authority

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes and Consultation

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. Therefore, a decision is due by **1 November 2024**.

On **23 October 2024**, a Freedom of Information Coordinator sent you an email informing you that the request cannot be processed under section 45(a)&(g) of the Act as the information is publicly available and is usually available for purchase. You were provided with the web link for ASIC ([ASIC search](#)) to purchase information related to UNV Contracting Pty Ltd. Information that is publicly available can be accessed through this link [UNV CONTRACTING PTY LTD - Search](#). I note that you have not withdrawn your request under this Act. Therefore, a formal decision is required.

Decision on access

I have decided to refuse to deal with your access application in full under section 45(a)&(g) of the Act, because:
