Freedom of Information Request – Block 33 section 19 and Block 13 section 18 Casey

I refer to your application under section 14 of the *Freedom of Information Act 1989* (FOI Act), received by the Environment and Sustainable Development Directorate on 16 November 2012, in which you requested the following documents:

"Documents ect, C1 and COU for the following houses 33/19 Casey & 13/18 Casey – [REDACTED]"

I am an officer authorised to make a decision in respect of a request for information, under section 22 of the FOI Act.

Schedule detailing decisions

Please refer to the attached schedule that lists decisions regarding access to all documents, which have been identified as relevant to your request. The terms used on the schedule are either 'Release', 'Partial release' or 'Exempt'. Where an exemption is made, a reference will be made on the schedule to the relevant section or combinations of sections of legislation that apply to the decision.

Decision

The Directorate has identified 3 documents in its possession that meet the scope of your request, as identified in the schedule attached to this letter. No Certificate of Occupancy and Use (CoU) can be located for Block 13 Section 18 Casey, no application for the CoU has been received by the Environment and Sustainable Development Directorate to date.

Under the FOI Act, documents may be exempt or provided to applicants with deletions and I have decided to exempt some documents under section 41 (Documents relating to personal privacy).

Personal Privacy

Section 41 of the Act provides

(1) A document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).

Two documents contain the personal information relating to community members and I believe that to release the information contained in these documents to you would constitute an unwarranted invasion of the privacy of the people concerned.

Review rights

My decision is appealable under the Act. This means that if you are dissatisfied with this outcome you have a right to seek a review under section 59 of the Act. This right of review extends to a review of the adequacy of the search for documents undertaken by the Directorate. If you wish to seek a review you should write to:

You have 28 days from the date of this letter to seek a review of the outcome or such other period as the Director-General permits.
