THE TERRITORY AND ORGANISATION AGREE:

a. The mutually preferred date for a tethered Appearance of The Skywhale at 'EWF' will be Saturday 2 November 2013 at 11am;

- b. In the Event the Appearance is cancelled on that day because of bad weather or winds, the Appearance will be conducted on the following day (Sunday) if suitable;
- c. The Territory has an existing engagement with, Global Ballooning Pty Ltd, who will act as the Operator for the Appearance at 'EWF';
- d. The 'Event' within which the Appearance of the Work occurs will be the responsibility of 'EWF' to manage, however, all operational responsibility for the Work will be the responsibility of Global Ballooning;
- e. Operational considerations will be respected by 'EWF' in their construction of the Event;
- f. Operational considerations relating to public safety will override other considerations in the management of the Event, and operational safety will be the responsibility of the operations team supplied by the Operator:
- g. Determinations of whether the weather is appropriate for an Appearance of the balloon on any particular occasion will be made by the operations team supplied by Global Ballooning:
- h. No monies will be transacted between the Territory and the Organisation;
- The Territory will make direct payment to Global Ballooning for the provision of the Work, crew and any operational infrastructure usually taken by the operator to the site of a tether location for like Appearances;
- j. Any additional expenses incurred relating to the Appearance or Event, including council permits or charges, road closures or other expenses, will be the responsibility of the Organisation;
- The Organisation will provide accommodation in-kind for the crew of the Operator;
- I. Any expenses incurred in managing and operating the Event within which the Appearance occurs will be the responsibility of the Organisation, including any crowd management, bollards, decoration or any other like requirement;
- m. The Organisation will invite the Artist, Patricia Piccinini, to the Appearance;

- The Organisation will liaise directly with Global Ballooning with respect to the

- s. Where undertaking marketing and publicity for the Appearance and Event, the Organisation will acknowledge the Centenary of Canberra through inclusion of logos and line acknowledgements on marketing and publicity material;
- t. Where space permits, the 'full logo lock up' of the Centenary of Canberra, including the Centenary of Canberra, ACT Government and ActewAGL logos should be used. This logo will be used at least on any website on which the Appearance is promoted;
- u, Where space is limited, the single Centenary of Canberra 'corporate' logo may be used alone;
- Wherever either logo is used, they will be accompanied by the line: The Skywhale is a Centenary of Canberra project, proudly supported by the ACT Government;
- w. Where promoting and publicising the Appearance of the Work, the Organisation should make prominent in copy that the Work is a commission by the Centenary of Canberra;
- x. Examples of copy used by and about the Centenary of Canberra and the project are available at www.theskywhale.com. The Territory would appreciate that such copy is accessed and utilised to ensure that the Work is placed in the context of the Centenary, its reputation for hot air ballooning, and the fact the Artist was raised in Canberra.
- y. Marketing collateral and media releases should be provided to the Centenary of Canberra, either to Julian Hobba <u>julian.hobba@act.gov.au</u> or Susanne Roberts (PR Manager) susanne roberts@act.gov.au for approval prior to distribution.

WARRANTY AND INDEMNITY

The Organisation ('EWF') indemnifies the Territory, its employees and agents, against liability in respect of all claims, costs and expenses in relation to all loss, damage, injury or death to persons or properly caused by the Contractor, in connection with the obligations under this Letter of Agreement, except to the extent that the Centenary of Canberra caused the relevant loss, damage or injury
- aa. The Territory Indemnifies the Organisation ('EWF'), its employees and agents, against liability in respect of all claims, costs and expenses in relation to all loss, damage, injury

or death to persons or properly caused by the Contractor, in connection with the obligations under this Letter of Agreement, except to the extent that the Organisation ('EWF') caused the relevant loss, damage or injury
