I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 8 September 2020, in which you sought access to:

• "We request any complaints received regarding truck noise or any other operational issues (waste compactor) pertaining to the ALDI Amaroo Store and ALDI Loading Dock between 2018-2020. Street address: 12 Pioneer Street, Amaroo ACT 2914."

Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 7 October 2020.

Decision on access

Searches were completed for relevant documents and one document was identified that falls with the scope of your request.
