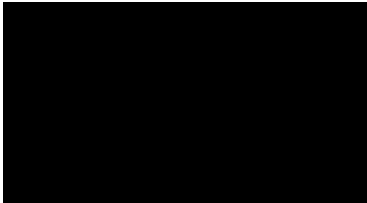

Freedom of Information Request – Question on Notice 776 Glebe Park

I am writing in relation to your request for documents on the above topic, submitted under section 14 of the ACT *Freedom of Information Act 1989* (the FOI Act) and received by the Land Development Agency (LDA) on 24 August 2016.

In your request, you are seeking “... *all documents generated within the Chief Minister's portfolio relating to Legislative Assembly Question on Notice 776 lodged on 10 August 2016 regarding the block of land adjacent to Glebe Park (City Block 24, Section 65).*”

Decision Maker

I am authorised under section 22 of the FOI Act to make decisions on access to documents in the possession of the LDA, and liability for charges.

Charges

I have decided, under section 29 of the FOI Act, not to impose processing charges for this request.

Identification of Documents

Officers of the LDA have conducted searches of paper and electronic files for documents that may relate to your request. Thirteen documents were identified and are provided with this letter and listed on the attached schedule.

Decision on Access

I have decided to fully release all 13 documents to you.

Your Right of Review

Internal Review

Under section 59(1) of the FOI Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Chief Executive Officer.

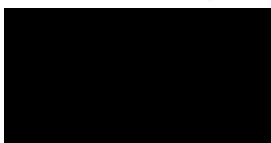
