Summary of Cabinet Outcomes Cabinet meeting of 5 February 2013

Autumn 2013 Legislation Program

Cabinet agreed to the Autumn 2013 Legislation Program, detailing priority Government Bills proposed for introduction in the Legislative Assembly during the Autumn session.

Government Response to Committee Inquiry into 2010-11 Annual and Financial Reports

Cabinet agreed Government responses to the reports by six Standing Committees of the 7th Assembly into 2010-11 Annual and Financial Reports, which were tabled throughout 2012. Statement of Government Policy: Land Policy and Development Objectives for 2013-14
