FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 27 February 2023, Specifically, you sought:

I request the following ministerial brief: CMTEDD2022/5099 Forward Three Year Trade Missions Planning

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 28 March 2023.

Decision on access

Searches were completed for relevant information and one document was found that falls within the scope of your request. I have decided to grant full access to that document and attachments. The information being released to you, is provided as Attachment A.

Statement of reasons

In reaching my access decisions, I have taken the following into account:

- the Act
- the content of the documents that fall within the scope of your request.

Information that would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act

Public Interest

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

In Hogan v Hinch (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it [public interest] appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors **favouring disclosure** in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
 - (i) promote open discussion of public affairs and enhance the government's accountability;
 - (ii) contribute to positive and informed debate on important issues or matters of public interest.

I have placed substantial weight on the above factors favouring disclosure. The release of this information can reasonably be expected to provide information that will inform the community and increase their understanding of government operations. The work and travel as part of the role of the Commissioner for International Engagement and the Office of International Engagement is an area of government that understandably attracts public interest and scrutiny. The release of this information provides some insight into the forward planning undertaken as part of this role.

I did not identify any factor favouring non-release and have decided to release this information to you in full.

Charges

Processing charges are not applicable for this request because the documents being released to you are less than 50 pages.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application and my decision in response to your access application will be published in the CMTEDD disclosure log. Your personal contact details will not be published.

Ombudsman Review

Background

- 1. The ACT Government established the role of Commissioner of International Engagement (CIE) and the Office of International Engagement (OIE) to ensure the coordination of international activity for the ACT Government.
- 2. In September 2016 the Chief Minister launched Canberra's *International Engagement Strategy* (IES) which identifies Canberra's seven key areas of strength and the ten primary markets with which the ACT will actively engage with.
- 3. Key to delivering the IES is a tailored and targeted calendar of international engagements. This will provide OIE an opportunity to build international relationships, identify opportunities for investment and partnership and promote Canberra as a destination for investment, trade, study, visit, and live.
- 4. The CIE with the OIE is responsible for "defining and implementing a targeted program of ACT Government, Ministerial and industry trade missions to priority markets".
- 5. The program will align with the ACT Legislative Assembly (ACTLA) Sitting Program.
- 6. The program also takes into account existing Sister City Agreements (SCA) and Memorandum of Understanding (MoU).
- 7. The proposed major missions for 2022/2023 FY are:
 - a. Singapore in August 2022;
 - b. New Zealand and Fiji in November 2022;
 - c. New Zealand in November 2022 (CIE only);
 - d. New Zealand in December 2022,
 - e. Singapore and Malaysia in February 2023;
 - f. EU and the United Kingdom in March 2023 (CIE only); and
 - g. Japan and South Korea in June 2023.
- 8. The proposed major missions for 2023/2024 FY are:
 - a. United Kingdom, France and Spain in July 2023;
 - b. United States of America in September 2023;
 - c. Thailand and Vietnam in October 2023 (CIE only);
 - d. New Zealand and Vanuatu in November 2023
 - e. Indonesia and Vietnam in March 202; and
 - f. Singapore and Thailand (post Budget) 2024. (184)
- 9. The proposed major missions for 2024/2025 FY are:
 - a. China in March 2025 (CIE only); and
 - b. Singapore and India in May 2025.
- 10. The proposed major missions for 2025/2026 FY are:
 - a. China in September 2025;
 - b. Thailand and Vietnam in October 2025;
 - c. New Zealand in November 2025; and
 - d. United States of America in May 2026.

- 11. The specialised objectives for each mission and cities to be included on the program will be determined closer to each trade mission, meeting your requirements, guided by the CIE and the IES, with consideration of emerging opportunities.
- 12. In consultation with your Office inclusion of a business delegation will be considered on a mission-by-mission basis. The OIE will then work with the Canberra Business Chamber to coordinate such delegations to accompany your trade missions.
- 13. The proposed program may need to be modified or added to accommodate future Australian Government activity if it meets the priorities of the ACT Government and IES.
- 14. The proposed program may need to be modified or added to should other opportunities arise.
- 15. The CIE would also undertake additional travel, within the constraints of available resources, for the purposes of:
 - a. Initiating and building relationships and program development; and
 - b. Negotiating specific agreements.
- 16. The consolidated program for the Chief Minister is at Attachment A.
- 17. The consolidated program for the CIE is at Attachment B.

Issues

- 18. Following agreement to a program of activity for the next three and a half years, the CIE will publish the proposed program with indicative dates to allow interested stakeholders to, where applicable, better integrate with the Chief Minister's program and better plan their own arrangements and budgets.
- 19. The Commonwealth still has in place restrictions on international travel due to the ongoing COVID-19 Pandemic. Any travel planning will be in accordance with restrictions and will ensure that the health of travelling members will be the outmost concern.

Financial Implications

20. Expenses will be met from within existing budgets for 2022/23. Future trade mission expenses will be the subject of a budget bid for the 2023/24 budget.
