

I refer to your request submitted under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 10 July 2018, in which you sought access under the *Freedom of Information Act 2016* (the Act).

Specifically, you sought access to "documents related to a meeting between the Chief Minister and Minister for Health on 25 January 2018. Documents related to a meeting between the Minister for Health and Head of Service on 2 February 2018."

Authority

l am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 7 August 2018.

Decision on access

A search for documents was conducted and resulted in 2 documents being identified in relation to the meeting between the Minister for Health and Head of Service. No documents have been identified in relation to the meeting between the Chief Minister and Minister for Health on 25 January 2018.
