#### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 20 October 2023.

Specifically, you are seeking:

"1. The results of the YourSay Panel Survey, conducted on behalf of CMTEDD, that closed in September of 2023 [as at 20 October 20223]."

## Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 1 December 2023.

#### Decision on access

A search of records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided. I am satisfied that appropriate searches were completed and that no documents within scope of your requested information are held.

## Additional information

The reason that no records are held within your requested scope is because at the time of making your request for information, the results have not been finalised. The survey referred to in your scope of requested information was only recently conducted. As the data and results are currently being analysed, the results, including draft reports, have not been completed.

Results from the YourSay Panel surveys are reported back to members of the community who took part in the survey and a final report is published on the ACT Government website. This normally takes place several months after the survey closes due to the amount of time required to analyse information collected and prepare a final report.
