FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 25 July 2018, in which you sought access to the actual number of notices issued for the offence of 'Stop in Bicycle Lane" occurring on each Sunday from and including 27 May 2018 to Sunday 22 July 2018.

Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 22 August 2018.

Decision on access

Searches were completed for relevant documents and 1 document was identified that falls within the scope of your request. Information not relevant to your request (namely the names of officers who supplied the information) has been redacted as 'out of scope' as your request sought only information about the actual number of notices issued.

I have included as **Attachment A** to this decision the schedule of relevant document. This provides a description of the document that falls within the scope of your request and the access decision for that document.

I have decided to grant full access to all relevant documents. The documents released to you are provided as **Attachment B** to this letter.

Charges
