## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 13 May 2022:

Specifically, you are seeking: "All documents/letters/correspondence relating to the Free Serbian Orthodox Church of St George in Canberra Diocese for Australia and New Zealand Incorporated including and Access Canberra on the following dates of 3 February 2022 and 4 February 2022. If there is anything else regarding either of these entities, close to these two particular dates, I would also require access to those documents as well. Anything regarding the registration of the new committee details on the 27 January 2022 and the reversal of that same registration."

#### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 14 June 2022 however, following an extension, and third-party consultation, the due date is now 19 July 2022.

#### Decision on access

Searches were completed for relevant documents and three documents were identified that fall within the scope of your request.

I have included as Attachment A to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant partial access to two documents relevant to your request. One document was found to be exempt as the information it contains was found to be contrary to the public interest information under schedule 1.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

### **Statement of Reasons**

In reaching my access decisions, I have taken the following into account:

- the Act
- the content of the documents that fall within the scope of your request
- the Information Privacy Act 2014

#### **Exemption claimed**

My reasons for deciding not to grant access to one document:

### Contrary to the public interest information under schedule 1 of the Act

The documents within scope of your request partially contain or are entirely composed of, information, that is considered to be contrary to the public interest under schedule 1 of the Act.

Schedule 1 covers information disclosure of which is taken to be contrary to the public interest to disclose unless the information identifies corruption or the commission of an offence by a public official or that the scope of a law enforcement investigation has exceeded the limits imposed by law.

Schedule 1, section 1.2 states:

## 1.2 Information subject to legal professional privilege

Information that would be privileged from production or admission into evidence in a legal proceeding on the ground of legal professional privilege.

Some documents contain information subject to legal professional privilege. Under section 1.2 of Schedule 1 of the Act, information subject to legal professional privilege is not considered to be in the public interest and is exempt from release. This information has been redacted.

Schedule 1, section 1.14(1)(f) states:

#### 1.14 Law enforcement or public safety information

1) Information the disclosure of which would, or could reasonably be expected to-

(f) prejudice the effectiveness of a lawful method or procedure for preventing, detecting, investigating or dealing with a contravention or possible contravention of the law.

One document contains information that if released, could reasonably be expected to identify investigative methods employed by Access Canberra's Licensing and Registrations unit. Revealing this information could reduce effectiveness of investigations conducted by Access Canberra.

The remaining documents contain information that would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act.

## What is the 'Public Interest'?

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which [they] appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

## Factors favouring disclosure in the public interest under schedule 2.1:

- (a) disclosure of the information could reasonably be expected to do any of the following:
  - (ii) contribute to positive and informed debate on important issues or matters of public interest

I consider that disclosing the contents of the information sought would significantly contribute to open discussion and informed debate on the matters contained in the documents. I am satisfied there is a public interest in discussing the content of these documents regarding the Committee of the Free Serbian Orthodox Church of St George in the Canberra Dioceses of Australia and New Zealand Incorporated, in addition to the application of government processes.

I am satisfied that these are relevant considerations favouring disclosure in this case, and in the interests of enhancing transparency and accountability, I afford them some weight.

I also note the FOI Act has an express pro-disclosure bias which reflects the importance of public access to government information for the proper working of a representative democracy. This concept is promoted through the objects of the FOI Act. I have considered this overarching concept in making my decision in relation to access.

## Factors favouring nondisclosure in the public interest under schedule 2.2:

(a) disclosure of the information could reasonably be expected to do any of the following:

(ii) prejudice the protection of an individual's right to privacy or other rights under the Human Rights Act 2004. I consider that the protection of an individual's right to privacy as a significant factor in deciding access to this information.

Individuals are entitled to expect that the personal information they have supplied to Government will be dealt with in a manner that protects their privacy. Considering the type of information to be withheld from release, I am satisfied that the factors in favour of release can still be met while protecting the personal information of the individuals involved. I therefore weigh the factor for nondisclosure more highly than the factor in favour of release in this instance.

Having applied the exemptions identified under schedule 1 of the Act, in addition to applying the test outlined in section 17, I have chosen to redact this specific information in accordance with section 50(2).

Noting the pro-disclosure intent of the Act, I am satisfied that redacting only that information that I believe is not in the public interest to release will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

### Charges

Processing charges are not applicable for this request because the number of pages to be released to you is below the charging threshold of 50 pages.

### **Online publishing – Disclosure Log**

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log after **23 July 2022**. Your personal contact details will not be published.

#### **Ombudsman Review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. 
