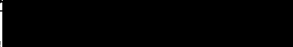

Incident details	This morning, [REDACTED] March, the Principal of Melrose HS noticed two police on bicycles riding around the outskirts of the school. Two calls were received this morning [REDACTED] alerting the school to an alleged brawl which took place yesterday afternoon in the new Park and Ride car park at the Mawson shops. This car parking area is on the corner of Mawson Drive and Athlon drive diagonally opposite the school. This brawl between students overflowed onto the road, preventing traffic from passing. [REDACTED] Staff on duty at the bus stops at the front of the school did not witness the event. The contact made this morning [REDACTED] was the first notification the school had received about the incident. The student services team at Melrose HS was able to quickly identify the [REDACTED] students who had been directly involved in the incident. A large number of students waiting at the Athlon Drive bus stop were drawn to watch the fight. The school has also identified [REDACTED] students who became involved [REDACTED] Students' parents have been contacted. [REDACTED]
