I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 17 March 2023. Specifically, you requested the following information:

- Any document that can be generated that identifies the number of staff working within CMTEDD who are working from a state/territory other than the ACT.
 Document to outline - 1. Classification (ASO4, SOG C, etc) 2. Number of people at this level working remotely and their locations.
- No personal information no names, no titles, no work areas. Just raw data as above.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 18 April 2023. Following on from your approval via telephone on 17 April 2023, the decision due date for this application is now 21 April 2023.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.
