#### FREEDOM OF INFORMATION REQUEST

I refer to your application received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 21 June 2018, in which you sought access under section 30 of the *Freedom of Information Act 2016* (the Act).

Specifically, you sought access to

## Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 19 July 2018.

#### **Decision on access**

A search of documents was conducted and the relevant business area has confirmed that the information you have requested is publicly available via the Tenders ACT contracts register and the ACT Government Notifiable Invoices Register. CMTEDD does not have further documents to provide in relation to your request. You can access the registers via the links below.
