Freedom of Information Request – 17/21460 – Lake Burley Griffin reclamation

I refer to your application under section 14 of the *Freedom of Information Act* 1989 (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 31 July 2017, in which you requested:

"A copy of the actual deed, licence or transfer arrangement between the Commonwealth and the ACT for the lakebed associated with what is known as Work Package 1 and Work Package 2 of the City to the Lake project in West Basin.

Any correspondence with on behalf of the ACT Government, its
Economic Development and Planning Directorate or the Land
Development Agency, regarding transfer of title, licence or use of the
lakebed for the West Basin foreshore reclamation project.
Any submissions, recommendations or presentations by the Land
Development Agency to the National Capital Authority Board regarding
the proposed use of lake bed in West Basin. This request is limited to
the period between 1 April 2016 and today.

Any survey data, drawings or charts in the ACT Government's possession, which illustrate any area to be reclaimed in West Basin. Copies of any requirements in the ACT Government's possession with regard to protection of the environment during the proposed West Basin developments, especially with regard to protection of water quality."

I apologise for the delay in providing you a response. Your patience and understanding throughout this process has been greatly appreciated.

I am an officer authorised to make a decision in respect of a request for information, under section 22 of the Act.



Decision

The Directorate has identified 68 items in its possession that meet the scope of your request, as indicated in the schedule attached to this letter. No submissions, recommendations or presentations to the National Capital Authority Board were identified.

The attached schedule outlines my decision regarding access to each of the documents identified as relevant to your request and the relevant exemptions applied. Documents are identified as either 'full release', 'partial release' or 'exempt'.

Exemptions have been applied under Section 34 (relations with Commonwealth and States), section 41 (documents affecting personal privacy), Section 42 (documents subject to legal professional privilege) and section 43 (business affairs). Some of the documents contain personal information and it is my determination that the release of this information would constitute an unreasonable disclosure of personal information. Some of the documents contain information and discussion about the negotiations about the lake bed reclamation. The release of this information could reasonably be expected to damage relations with the Commonwealth by revealing information that formed negotiations or was about them. This information is therefore exempt under section 34. Some of the documents contain names, contact details and other information about persons, which is exempt under section 41. Some of the documents contain communication with and advice from the ACT Government Solicitor, and are thus exempt under section 42. Some of the documents are property or land valuations, or contain information relating to such valuations, or are reports related to environmental management. The release of these documents could have a negative impact on the professional or commercial affairs of the businesses involved by revealing business information, and they are thus exempt under section 43.
