I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 17 October 2019, in which you sought access to the Strategic and Functional Review of the ACT Public Sector and Services .

Specifically, you are seeking:

a copy of the 'Strategic and Functional Review of the ACT Public Sector and Services', which was provided to the ACT government early in 2006. The document advised the government on the 2006-07 budget.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 14 November 2019.

Decision on access

I am unable to deal with your application because the document is an accessible executive record under the *Territory Records Act 2002* and therefore pursuant subsection 13(1) of the *Freedom of Information Act 2016* your request cannot be processed under this Act.

Your request has been provided to the Head of Service in her role as principal officer for the ACT Executive under the *Territory Records Act 2002*. The Head of Service is considering your request for the document under this Act and you will receive a response shortly.
