# FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 25 November 2022 in which you sought access to:

Specifically, you are seeking:

- 2. I wish to be provided with the entire Operating/User Manual provided to the Department which uses and manages the above mentioned camera
- 3. I wish to be provided with the statistical information of how many cars were issued with speed infringement notices on that particular date (being 12/02/2022). There is no need for me to have any private information only statistical information of the number of cars
- 4. I wish to be provided with the statistical information of the speeds at which the cars that were issued with speed infringement notices on that particular date (12/02/2022) were travelling
- 5. I wish to be provided with comparative statistical information of Saturdays for the year from when the abovementioned camera was installed to the 12/2/2022 (inclusive) for statistics requested in points 4 and 5 above
- 6. I wish to be provided with photographic and graphic depicting the signage both as erected signs and painted on the roads from the commencement of the 40kms speed limit and leading to the position of the intersection of Northbourne Avenue/Barry Drive/ Cooyong Street

## Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by **23 December 2022.** 

### **Decision on access**

Searches were completed for relevant information that falls within the scope of your request. The information being released to you, is provided as **Attachment A.** 

For parts 3, 4, 5 and 8 of your access application, the information is publicly available and can be derived from <u>https://www.data.act.gov.au/Transport/Traffic-camera-offences-and-fines/2sx9-4wg7</u>, and as such is exempt under section 43 (1)(d) to be disclosed pursuant to section 45 (a).

Parts 6 and 7 of your access application were transferred to the Transport Canberra and City Services Directorate (TCCS) on 7 December 2022 under section 57 of the Act. TCCS responded to you on 16 December 2022.

# Public Interest

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and nondisclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which [public interest] appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act. Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors favouring disclosure in the public interest under Schedule 2 s2.1:

(a) Disclosure of the information could reasonably be expected to do any of the following:

*(ii) contribute to positive and informed debate on important issues or matters of public interest.* 

(iii) inform the community of the government's operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with

### members of the community.

Information concerning public safety measures, including speed cameras, used, and maintained in the community can reasonably be expected to inform public debate. I have considered the information being released and believe it could also inform the community about policies and guidelines followed by government.

There are no factors favouring nondisclosure of this information.

### Charges

Processing charges are not applicable for this request because the total number of pages to be released to you does not exceed the charging threshold of 50 pages.

### **Online publishing – Disclosure Log**

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and information released to you will be published on the CMTEDD disclosure log. Your personal contact details will not be published.

#### **Ombudsman Review**
