FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 6 July 2022.

Specifically, you are seeking: access to 120 Ministerial briefs, in addition to all question time briefs for the period 10/03/20022 - 10/04/2022. [These Ministerial briefs had been identified in a previous access request, refer CMTEDDFOI2022-129].

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 3 August 2022.

On 1 August 2022 I wrote to you proposing to refuse to deal with your request as it would require an unreasonable and substantial diversion of resources pursuant to section 44(1) of the Act. In that letter you were provided with the opportunity to amend your application. The time allowed for your response to my proposal, as stated under section 46(4)(a) was 10 working days meaning a response was due to this office by 15 August 2022. I did not receive a response by that date.

Decision on access

I have decided to refuse to deal with your application under section 43(1)(a) as an unreasonable and substantial diversion of resources.

Charges

Processing charges are not applicable for this request because no pages are being released to you.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. A description of the access application and my decision will be published in the CMTEDD disclosure log after 3 days after the date of my decision. Your personal contact details will not be published. Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day of my decision, or a longer period allowed by the Ombudsman.
